Why in news?

Recently, India has officially joined the International Big Cat Alliance (IBCA), which was launched by the Prime Minister in 2023

• IBCA aims to protect big cats and their habitats.

Note:

• Though India launched**the International Big Cat Alliance (IBCA)**as a global institution, it must still sign and ratify its Framework Agreement, similar to its approach with other international agreements and institutions, such as the <u>Paris Agreement</u>, the <u>Convention on Biological Diversity (CBD)</u>, and the <u>Shanghai</u> <u>Cooperation Organization (SCO)</u>.

About IBCA

- International Big Cat Alliance(IBCA) is amulti-country,multi-agency coalition of 96 big cat range countries, non-range countries interested in big cat conservation, conservation partners and scientific organizations working in the field of big cat conservation besides business groups and corporates, to establish networks and develop synergies in a focused manner.
- Its idea was1stfloatedby India's Prime Minister in2019.
- It was launched in April 2023 to celebrate the 50th anniversary of Project Tiger.
- The Union Cabinet had allocated a one-time budgetary support of Rs150 crorefor IBCA for a five-year period —2023-24 to 2027-28.
- It aims at conservation of seven big catsnamely <u>Tiger</u>, Lion, Leopard, Snow Leopard, Cheetah, Jaguar, and Puma.
- **Objectives of IBCA:**
- To stop the illegal wildlife trade of the seven big cats.
- To work towards the conservation of natural habitats of the seven big cats.
- Mobilisation of financial and technical resources for implementing the conservation and protection agenda.

Governing structure

- It will consist of anAssembly of Members,Standing Committee and aSecretariat, with itsheadquarters in India.
- ItsFramework of Agreement(statute) has been drafted largely on the pattern of the International Solar Alliance.
- The statute of IBCA will be finalised by an**International Steering Committee**.

Big Cats

- 'Big Cat'is a term that is used to apply to anylarge species of the family *Felidae*. Usually, it applies to the members of the genus *Panthera*. These include:
- 1. Tiger(Panthera tigris)
- 2. Lion(Panthera leo)
- 3. Jaguar(Panthera onca)
- 4. Leopard(Panthera pardus)
- 5. Snow Leopard(Panthera uncia)
- Two other cats, i.ePuma(*Puma concolor*)andCheetah(*Acinonyx jubatus*), arenot part of Panthera. But they are usuallyincludedin most listings of 'big cats'.
- All these cats can usually makevocalisationsknown as 'roars'.
- The Indian subcontinent has been historically home to the Bengal tiger, Asiatic lion, Indian leopard, Indian/Asiatic cheetahas well as Snow leopard.
- The cheetah was declared extinct in 1952. In 2022, the Government of India embarked on an ambitious programme to introduce African cheetahs to the Kuno National Park in MP.
